- B. Street Closures. The Mayor and Town Council shall discuss and possibly take action on a request by the Town Parks & Recreation Department to close the southbound lane of Euclid Street, northbound lane of Scott Street, the westbound lane of Papago Street and the eastbound lane of Hunt Street, leaving the lane closest to the residences open for travel on November 21, 2009 for the First Annual Car Show. **Discussion and Action.** (LILAC)
- C. Shrimp Festival Permit.
