

ORDINANCE NO. 20-02

AN ORDINANCE OF THE COMMON COUNCIL OF THE TOWN OF GILA BEND HEREBY AMENDING THE TOWN CODE, MORE PARTICULARLY SECTIONS 38.02(A), SPECIAL COUNCIL APPROVAL REQUIRED, AND 38.06, QUOTATION OR BID REQUIREMENTS, AS HEREINAFTER PROVIDED, AND DECLARING AN EMERGENCY

WHEREAS, the Common Council of the Town of Gila Bend in order to more effectively address current economic conditions and needs of the community hereby amend by update the following provisions of the Town Code for purchasing requirements;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE TOWN OF GILA BEND, AS FOLLOWS:

Section 1. That the Common Council of the Town of Gila Bend hereby amends the Town Code of the Town of Gila Bend, more particularly, Section 38.02(A), "Special Council Approval Required", as follows:

38.02 SPECIAL COUNCIL APPROVAL REQUIRED

(A) Council approval shall be required in advance for the solicitation of sealed bids for all capital expenditures of more than ***\$25,000.00***.

Section 2. That the Common Council of the Town of Gila Bend hereby amends the Town Code of the Town of Gila Bend, more particularly 38.06 "Quotation or Bid Requirements", as follows:

38.06 QUOTATION OR BID REQUIREMENTS

Except as provided in Sections 38.07 through 38.13, prior to purchase of goods or services, quotations or bids shall be sought according to the following schedule:

Dollar Range	Quotation or Bid Requirements
<i>\$0 - \$4,999</i>	Whether quotations or bids sought shall be at the discretion of the Town Manager
<i>\$5,000 - \$9,999.99</i>	A minimum of 3 telephone quotes shall be sought
<i>\$10,000 - \$24,999.99</i>	A minimum of 3 written quotes shall be sought

\$25,000.00 and up

Formal solicitation with newspaper advertising with requirement of sealed bid shall be sought from a minimum of 3 suppliers / vendors. The Town may waive the sealed bid and/or advertisement requirements when determined it's in the best interest of the Town, ***or an emergency is declared.***

Section 3. WHEREAS, the immediate operation of this Ordinance is necessary for the preservation of the public peace, health and safety of the Town, an emergency is hereby declared to exist, and this Resolution shall be in full force and effect from and after its passage, adoption and approval by the Mayor and the Common Council of the Town, and it is hereby exempt from the referendum provisions of the Constitution and laws of the State of Arizona.


